## 9.0 Challenges

The following challenges have been faced:

- Budget constraints which affected the attendance of physical meetings by all members of WG4.
- Lack of commitment of some Working Group members.
- Inconsistency in attending WG meetings by members.
- Poor internet connectivity which affected online attendance of meetings by some members.

## 10.0 Recommendations

- 10.1 The need for all member Designated Operators to install the Global Monitoring System (GMS) to measure Quality of Service as a requirement of UPU for remuneration purposes
- 10.2 Each member country should set-up an e-commerce website where customers can sell and buy merchandise and for the post to do last mile delivery.
- 10.3 Each member state should implement the new UPU requirements regarding Electronic Advance Data (EAD), remuneration, quality of service and postal security certification.
- 10.4 All member countries should utilize the UPU Quality of Service Fund (QSF) to implement quality improvement related projects.
- 10.5 Each country should designate a permanent member of the WG4 to ensure continuity of participation and consistence.

## 11.0 Consideration of cross-cutting issues for submission to the Joint Committee

It was agreed that the following cross – cutting issues be forwarded to the Joint Committee:

- i. Addressing & Postcodes: Postal cannot succeed addressing system and cannot afford e-commerce without support.

- ii. Universal Service Fund (USF) to support postal services. In many countries, USF is under National Regulatory Authorities (NRAs) and there is a need to contribute to the development of postal sector
- iii. Greening postal services: postal services not to affect the environment by using solar panels to manage e-waste,

## 12.0 Conclusion

The Postal Assembly:

- a. Adopted the report of outgoing chairperson of the Assembly.
- b. Noted and adopted the progress report of WG4 on Postal and Courier Service Development and Regulation.
- c. Encouraged the WG4 to continue working on the tasks in progress and, to start the new activities in Strategic Plan 2023-2028.

The Chairperson of the Postal Assembly thanked all the participants for their achievements and encouraged them to continue improving. He thanked them also for their contributions during the Assembly meeting.
