

The Producer Responsibility Organisation (PRO).



The PRO

- Organises the compliance of producers with EPR legal obligations and targets
- Platform **linking** private and public **stakeholders**
- **Transparent** vehicle guaranteeing accountability
- Self-financing, funded by producers, generally in proportion of market share
