

REPORT OF THE PROCEEDINGS OF THE

25RD EAST AFRICA COMMUNICATIONS ORGANIZATION (EACO)

CONGRESS

30TH JUNE 2023

ROYAL PALACE HOTEL, BUJUMBURA, BURUNDI

1.0 INTRODUCTION

The 25th EACO Congress meeting was held on the 30th June, 2023 at Royal Palace Hotel, in Bujumbura, Burundi. The meetings for the Working Groups and Committees, the Assemblies of Regulators, Telecommunications, Postal and Broadcasting Operators together, the signing of the Cross Border Frequencies Coordination Agreements, the Stakeholders' Dialogue on topical issues in the Communication sector, and EACO Executive Committee preceded the Congress at the same venue from 26th to 29th June 2023.

This report presents the proceedings and decisions of the Congress after considering the reports of the Assemblies, Human Resource Committee, Legal and Constitutional Affairs Committee, and the Finances & Risks Management Committee.

3.0 OPENING CEREMONY FOR CONGRESS

3.1. Remark by the Executive Secretary of EACO – Dr. Ally Simba

The Executive Secretary welcomed all delegates in their respective capacities to the 25^{th} EACO Congress.

He thanked Burundi, through Agence de Regulation et de Controle des Telecommunications (ARCT), for hosting the year's Congress as well as the consistent support in all areas of our endeavor to achieve EACO objective.
