



**REPORT OF THE PROCEEDINGS OF THE
29TH EACO ASSEMBLIES & EXTRAORDINARY
CONGRESS
24TH – 28TH JUNE 2024
SAFARI PARK HOTEL & CASINO, NAIROBI, KENYA**

1.0 INTRODUCTION

The 29th EACO Assemblies and Extraordinary Congress were held from 24th – 28th June 2024 at Safari Park Hotel & Casino, Nairobi, Kenya. The meetings for the Working Groups and Committees, the Unveiling of EACO Regional Statistics for 2023, two workshops (on telecom & postal sectors) preceded the Assemblies while a workshop on Universal Service Fund was held on Day 4 of the week (27th June 2024).

The Extraordinary Congress was held on 28th June 2024 and was dedicated to amendment of EACO constitution.

This report presents the proceedings and decisions of the Assemblies and the Extraordinary Congress after considering the reports of Working Groups and Committees.

4.3. Key recommendations

- To embrace the technology through capacity building;
- Sharing experience;
- To ensure that required budget is allocated to institutions dealing with digital transformation;
- To be digitally ready and to secure the cyberspace, e.g. digital authority ensures provisions on data protection;
- To consider the industry sector as a development partner.

The workshop's theme was *“Role of ICT in Promoting Digital Transformation in the Region”*.

The purpose of having the workshop was to ensure that the Communication sector is engaged in discussions on topics that are relevant to the Assemblies and make necessary recommendations relevant to the region.

A keynote address was delivered by Ms. Beata Mukangabo, General Manager at Rwanda Utilities Regulatory Authority (RURA) on behalf of Mr. Everiste Rugigana, Director General, (RURA). The following were the key recommendations from the workshop:

- Review National building codes in EAC Member States to ensure provisions for fiber pre-deployment to facilitate fiber-optic cable in the future given the core foundation role that it plays in the Digital Economy.
- Member States were urged to address ICT infrastructure financing gaps by exploring different financing options
- They were also urged to ensure Private Sector participation, encourage Foreign Direct Investment (FDI) in the ICT sector.
- Create an enabling environment through harmonised policy and regulatory frameworks and make Africa an investment destination
- Include ICT in National Investment plans, have unified licensing regimes, encourage infrastructure sharing to reduce on CAPEX.
- Capacity Building to build skills for the African workforce
- Innovation and adoption of Emerging Technologies such AI
- Enhance collaboration and partnerships (Public Private Partnerships).

5.2 Postal workshop

The workshop was held under the theme “*Promoting e-commerce in postal & courier services*”. The objective of the workshop was to make aware industries of the postal sector on the need of promoting e-commerce in postal & courier activities and operations and; then discuss on the strategy of promoting e-commerce in postal & courier services in East Africa region.

The moderator was Mr. Ferdinand Christian Kabyemela, from Tanzania Posts Corporation (TPC), Chairperson of WG4 on Postal and Courier Services Development & Regulations.

In order to promote e-commerce in postal & courier services, the following recommendations have been made:

- Government has to create an enabling environment for digital services provision
- Posts to establish partnerships to provide wider e-commerce solutions to meet market demands
- There must be payment solutions to facilitate cross border trade
- Post to upscale delivery and logistics operations

5. 3 Workshop on Universal Service Fund (USF)

As part of the Assemblies and Congress, a workshop coordinated by the GSMA in partnership with EACO held a workshop on Closing the Connectivity Gap in Africa through USF reforms.

The workshop that was moderated by Ms. Caroline Mbugua HSC, Senior Director Public Policy and Communications SSA, GSMA started with a Country case study for Tanzania and this was

presented by Ms. Justina Mashiba, the CEO of UCSAF Tanzania. In her presentation, she highlighted the functions and responsibilities of UCSAF, sources of funds, key projects that have been implemented in Tanzania and the challenges that the fund faces.

This was followed by a presentation of the report of the study on USFs in Africa. The which was conducted by the GSMA in collaboration with the Africa Telecommunication Union (ATU). The extensive study provided an in-depth analysis of the status, success factors and challenges of USFs in Africa. It also highlighted that at least 51 of the 54 African countries introduced or are introducing the Universal Service Fund (USF) mechanism to deploy mobile broadband infrastructure in commercially unviable areas with the intention of bridging the connectivity gap. In all cases, USFs are partly or entirely financed through contributions from telecom service providers. The study aimed at producing evidence to support policy reforms, where needed, to enhance the impact of existing funds on the connectivity gap. The report proposed eleven key reforms to address factors limiting performance of USFs and to enhance their effectiveness in closing the coverage and usage gaps. These included;

- Adopt mechanisms to incentivize the disbursement of funds. Establish clear targets and use incentives to ensure effective and timely disbursement.
- Implement an evidence-based contribution rate—A suitable contribution rate should be decided using an evidence-based approach in consultation with service providers.
- Set clear and measurable targets for the USF – Clearly define the parameters for USF projects and outline key success measures following implementation.
- Priorities stakeholder consultation – Stakeholder consultation should not be a one-off or an occasional call for submissions; rather, it should be a continuous engagement process, with direct contributions and feedback from service providers.
- Use a data-led approach to selecting USF projects—Data gathering and efforts to apply relevant insights to project selection should form part of the operational reform of USFs.
- Ensure regular performance monitoring and reporting – Regular reporting is paramount to provide visibility and accountability.
- Establish a project costing system that accounts for overheads – A comprehensive costing system should account for overheads and OPEX from the outset, with a sustainable solution that guarantees the long-term viability of a USF project.
- Explore alternative funding mechanisms – The ‘pay or play’ model adopted in Morocco is an example of an alternative model with the potential to incentivise investments in coverage expansion and tackle the challenges associated with the traditional USF model.
- Build capacity and develop skills within the USF – Focus on reskilling and upskilling existing personnel, recruiting new people and retaining qualified staff at the USF authority.

- Engage with local communities on the benefits of connectivity – Take steps to engage with consumers and community leaders to address any perceived concerns about digital technology.
- Consider an independent governance structure – Seek to minimise or eliminate red tape and political interference in managing funds and implementing USF projects.

The workshop was concluded with a Panel discussion under the theme “Effectiveness of USFs in addressing the connectivity gap in the region”.

The panelist included;

- 1) Hon. George William Nyombi Thembo, Executive Director, UCC.
- 2) Fred Waithaka- Chief Corporate Affairs Officer, Safaricom PLC.
- 3) Mr. William Baraza, Director, AFRALTI.

The discussions included the areas that Member States could tap into to improve the effectiveness of USFs in the region. These included;

- Collaboration that could be institutionalised
- Digital skilling. This would enable effective utilization of many interventions put in place by USFs
- Address the sustainability question which affects most of the projects established by USFs
- Review the mandate of USFs
- Use appropriate models like the Public Private Partnership to reduce the connectivity/usage gap
- Consider having MNOs on USF Boards.
- The USFs should look beyond the Telcom companies and also include other sub sectors like postal, however some highlighted that USFs benefit members so postal service providers should be encouraged to contribute to USFs however little the amounts could be.

The panel discussion was concluded with a recommendation to form the Assembly of USFs in the region or a working group specific to USFs given the role they play in addressing the connectivity gap in the region coupled with their growth rate.
